- **4.1** This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **BADVE AUTOTECH PVT. LTD.** the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of Training Partner or **BADVE AUTOTECH PVT. LTD.** the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
- **4.2** Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
